HERITAGE ADOPTION SERVICES FEE SCHEDULE AND AGREEMENT ADOPTION FROM THE PEOPLE'S REPUBLIC OF CHINA WAITING CHILD/SHARED AGENCY PROGRAMS

We agree to pay each of the fees outlined below and understand that some of these fees are paid directly to Heritage and others are forwarded to other agencies/persons for services.

ADOPTION EXPENSE IN THE US

Due at the time of application	
Agency Fee: Part 1 (-)	\$3,250
Due with first set of dossier documents submitted	
Parent Preparation Program* (-)	\$250
Due during dossier collection and prior to starting preparation program	
Agency Fee: Part 2 (-)	\$2,100
Due after Dossier to China (DTC) date	
US Citizenship and Immigration Costs*	\$670 + \$80/each adult in home
Due at time USCIS I-600a is filed, paid to USCIS	

HOME STUDY (-)

Initial Visits and Reports (-)	\$1,500
Due at the time home visits begin, Heritage can complete home studies for families in OR, WA, or MT	
Travel and Mileage	\$20/hour driving time + \$.485/mile
Families living significantly outside of our office areas will need to reimburse the home study writer for travel expenses. Mileage is charged at the federal mileage rate, plus \$20 per hour of travel time. Hotel and airfare may also apply. Paid directly to home study writer and due at time of visit.	
Addendums or Updates (-)	\$100 - \$350
Due at the time the addendum or update is completed, only when required because of a change in adopting family circumstance or due to length of adoption process.	
Certificate of Approval for Home Study	\$100
Paid only when a home study is completed by an agency other than Heritage. Due at the time home study is submitted to Heritage for review and approval.	

*NOTE: Families living in other states should expect to pay between \$1000 and \$3500 for fees paid to a licensed child placement agency for home study services

TRANSLATION AND DOCUMENT EXPENSES

Costs of obtaining and shipping documents*	varies
Document Authentication Fees* (-)	\$80 per doc.

 Paid at US Embassy, in exact US Cash, in Guangzhou
US Embassy Medical Visit* **approx. \$75**
 Paid at Guangzhou Medical Office, in RMB or US cash

CONTRIBUTIONS

CCAA mandated Orphanage Donation* **\$3,000**
 Paid in advance of travel, whenever possible, or carried to China in US, amount subject to change.

TRAVEL AND ACCOMMODATION EXPENSES*

approx. \$2600 - \$3600

Varies depending on number of persons traveling, length and location of stay in China, etc. Due prior to travel.
 Families are responsible for arranging their own air travel to and from China.

POST ADOPTION

Post Adoption Reports (-) **\$300**

Due at first post adoption visit, applicable only to families in OR, WA, or MT
 NOTE: Families living in other states should expect to paid between \$200 and \$1000 in fees to a licensed child placement agency for post adoption services
 NOTE: Two reports are required by CCAA; one due at 6 months and another due at 12 months from the date of placement, unless citizenship and re-adoption requirements are not met, in which case additional reports will be required by Heritage Adoption Services (see Adoption Services Agreement for more information)

Re-adoption Expenses* **approx. \$350 - \$800**

Paid to US attorney, varies by attorney and state of residence – covers re-adoption process in adoptive family's state of residence, may or may not include court filing and certificate fees.

APPROXIMATE TOTAL COSTS OF PROGRAM

For families living in Montana, Oregon or Washington **Approx. TOTAL \$16,765 – \$19,775**

Of the above total \$12,450 are "fixed" costs, though subject to change
 Of the above total \$4,305 to \$7,325 are "variable" costs

For families living in all other states **Approx. TOTAL \$16,165 - \$22,475**

Of the above total \$10,750 are "fixed" costs, though subject to change
 Of the above total \$5,415 to \$11,725 are "variable" costs
